BOARD HIGHLIGHTS

End of the Board's Term

Board Chair, Mrs. Anita Anctil, highlighted that this meeting marked the last gathering and the end of the current Board of Trustees' term.

She thanked outgoing trustees, Mrs. Sylvianne Maisonneuve and Mr. Pascal Leclerc, for their years of service and dedication to francophone education. A recognition evening will be organized following the elections.

At the close of Nomination Day on September 22, three members were elected by acclamation:

- Anita Anctil (Ward 2 Catholique),
- Roger Tremblay (Ward 3 public), and
- Luc Levesque (Ward 4 public).

The final composition of the new Board o Trustees will be determined in the school elections on October 20, as two wards are still contested: Ward 1 Catholic and Ward 3 Catholic.

The new Board of Trustees will be sworn in at the organizational meeting on October 28, 2025.

Superintendent's Report

Increase in Student Enrolment: Preliminary numbers indicate a notable increase of enrolment at the CSNO. The official enrolment numbers will be determined on September 30.

2024-2025 Education Results: Preliminary analysis shows overall positive results. However, access to services remains a key issue to monitor.

Legislative Changes: Several recent changes to provincial laws and ministerial regulations will impact on the CSNO's administrative directives. The administration is working to make the necessary updates.

Heating Issues at École des Quatre-Vents: The school's heating system has experienced malfunctions since opening. The situation is considered critical, and steps are being taken to
