

BOARD HIGHLIGHTS

2025-2026 Budget Update

The CSNO'S 2025-2026 budget adjustment shows increased funding, thanks to a significant increase in the nutrition program subsidy, following the agreement between the federal and provincial governments for the National School Food Program. The instructional budget also saw a slight increase, reflecting enrolment growth and salary adjustments for certified staff under the new collective agreement.

Trip to Quebec - ÉNF

The Board approved École Nouvelle Frontière's trip to Quebec, which will take place from June 23 to July 2, 2026, for students in grades 7 to 9.

School Councils Meeting

School councils are invited to the annual meeting with school trustees to be held on March 24 in St-Isidore, a valuable opportunity to discuss the CSNO's strategic framework. In addition, the trustees have committed to resuming their participation in school council meetings.

Recognition evening

A recognition evening was held on January 6 to acknowledge the commitment and years of service of the outgoing school trustees: Sylvianne Maisonneuve (12 years old), Mario Paradis (18 years old) and Pascal Leclerc (4 years old).

Governance Training

School trustees and administrators are participating in the **Professional School Trustee Designation Program**. This governance training program, offered by the Centre for Excellence in organizational Governance, consists of 40 hours over two years and leads to a micro-credential from the University of Sudbury. The first session took place in Edmonton on December 5 and 6, with the remainder of the program to be delivered through virtual and in-person sessions.

Superintendent's Report

Updates were provided on the implementation of the *Value Scoping* projects for pre-planning in Slave Lake and High Level. A letter of interest has been received from a family in Slave Lake, and a meeting with the Town of Slave Lake will take place in the coming weeks. Regarding the 2026-2027 school calendar, the administration is favouring a more uniform approach across the three schools, and a draft will be submitted in March. Efforts continue to secure adequate funding to address issues with the heating system at École des Quatre-Vents, including a letter to Alberta Infrastructure.
