

## BOARD HIGHLIGHTS

### 2027-2030 Capital Plan

The School Board approved the 2027-2030 Capital Plan, with the following priorities:

- Priority # 1 – New School in Grande Prairie
- Priority # 2 – New Program in Slave Lake
- Priority #3 – Study for a program in High Level.

The Capital Plan will be available on the CSNO website by early April.

### 2026-2027 Budget Forecast

The Board received information regarding the 2026-2027 provincial education budget. An initial analysis will be conducted based on the available information and further refined once the Funding Manual is released. The CSNO's 2026-27 budget is scheduled for approval in May.

### 2026-2027 School Calendar

The 2026-27 school year calendar was approved as proposed, with a unified schedule for all three schools.

## BOARD HIGHLIGHTS

### Classroom Size and Complexity Funding

The required information on class size and complexity has been submitted to Alberta Education and Child Care. The CSNO has received \$300,000 in funding for a Complexity Team. A special request was submitted to allow flexibility in allocating these funds based on actual needs; a response is still pending.

### School Infrastructure

**Pre-planning Projects:** The Value Scoping report for a second school in Grande Prairie was submitted to the government at the end of February. Work is also ongoing for pre-planning projects in High Level and Slave Lake, including meetings with municipal councils and the upcoming selection of an engineering firm to complete the reports.

**École Héritage:** Modernization work is ongoing.

**École des Quatre-Vents:** Steps are continuing regarding the recovery of expenses related to the school's heating system.

### Administrative Procedures
